5. Bids shall be opened in presence of Bidders' representatives who choose to attend on ***12:15 noon on 2083/01/24 (May 07, 2026)***. at the office of ***Benighat Rorang Rural Municipality, Bishaltar, Dhading***. Bids must be valid for a period of ***31<sup>th</sup>*** counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of ***Rs. 4,00,000/-***, which shall be valid for minimum 30 days beyond the bid validity period.
6. Pre-bid meeting shall be held at ***Benighat Rorang Rural Municipality, Bishaltar, Dhading*** at ***2083/01/15. 13:00 PM***.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
