5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2083/01/09, 12:15 PM at the office of Benighat Rorang Rural Municipality, Bishaltar, Dhading. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs 30,000/- , which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in **Deposit Account No. 0830094636300051** at **Prabhu Bank Ltd., Benighat Branch** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
